<p><b>DETAILS:</b> At approximately 3:56 p.m. this same date, Loveland Police responded to a report of a male photographing the intimate parts of a juvenile male inside a restroom at North Lake Park. The juvenile male was alarmed and alerted his parents who were nearby. The juvenile was not physically harmed in the incident.</p> <p>The victim's parents immediately phoned Loveland Police, and a patrol officer arrived at the park almost immediately. The officer located the suspect as he was leaving the park in his vehicle, a white 1994 Chrysler LeBaron bearing Colorado registration plate 631-VJI. When the officer attempted to stop the suspect he fled westbound on 29<sup>th</sup> Street in his car. The officer pursued Mayer for a short while, but discontinued the pursuit in the interest of public safety when Mayer allegedly drove into oncoming traffic and accelerated to a high rate of speed.</p> <p>Loveland Police identified the suspect as Jakob Reuben Mayer, date of birth 12/24/1981. Mayer is a white male, 5'5" tall, weighing approximately 230 pounds, with brown hair and brown eyes. <p><b>Updated information:</b></p> <p>On June 6<sup>th</sup>, 2011 at approximately 7:30 pm, JAKOB MAYER was arrested by the Colorado State Patrol in Jackson County after a short vehicle pursuit resulting in MAYER crashing his vehicle. MAYER was air lifted to the Medical Center of the Rockies (MCR) in Loveland with non life threatening injuries. The Loveland police department will be charging MAYER with the following criminal offenses: Sexual Exploitation of a Child (C.R.S. 18-6-403(3)(d)), a Class 6 Felony, Obscenity (C.R.S. 18-7-102(2.5)(A)(II)) a Class 6 Felony and Vehicle Eluding (18-9-116.5) a Class 5 Felony as amended.</p>			
<p>*The criminal charges are only allegations and the defendant is presumed innocent until proven guilty at trial.</p>
